INTRODUCTION

This handbook has been developed to assist families in understanding *who* Crown of Life Christian Academy (“CoLCA”) is and introduce them to its policies and procedures. ***This handbook will be updated periodically and should be read by all school families.*** If there are questions concerning any of the school's policies or procedures, we ask that you bring them to the Principal or the Education Committee.

SCHOOL STRUCTURE AND GOVERNANCE

CoLCA is governed by the Education Committee in consultation with the Church Council of Crown of Life Lutheran Church. Under the Church Council, the school maintains the following structure:

Crown of Life Lutheran Church’s Education Committee establishes policies and procedures and advises the Church Council on matters regarding CoLCA’s educational ministry. The Chairman of the Education Committee is a voting member of the Church Council.

The Principal is tasked with overseeing the daily operations of CoLCA and is responsible for carrying out all school-related tasks including supervision of instruction, discipline, staffing, and administrative duties.

Classroom teachers are directly responsible for their classroom and their students. Families are encouraged to speak regularly with their child’s teacher regarding the progress of their child and any feedback (whether positive or constructive) and concerns they want to express.

The **Education Committee** of Crown of Life Lutheran Church is thankful for the opportunity to partner with you in *helping your child become all Christ calls them to be*. The Education Committee stands ready to serve families by striving to provide an outstanding educational experience for your child. May the Lord bless our partnership.

MISSION, VISION, AND OBJECTIVES OF CROWN OF LIFE CHRISTIAN ACADEMY

CoLCA functions as part of the overall ministry plan of Crown of Life Lutheran Church and seeks to carry out the campus-wide mission of...

"To Know Christ and Make Christ Known"

This mission is carried out on campus and in the community. With the all-powerful Word of God, Crown of Life will encourage God's people to grow into all they have been designed to be and reach out into the community to those who may not yet know Jesus as their Savior from sin.

VISION STATEMENTS

To carry out its mission, CoLCA commits itself to collaborate with families to accomplish the following:

- Partner with parents/guardians in fulfilling their God-given responsibility of bringing up their children in the training and instruction of the Lord (Ephesians 6:4).
- Help students discover and develop their talents and abilities to be used in thankful service to the Lord.
- Encourage students and their families to have a life-long relationship with Jesus Christ.
- Provide a safe, nurturing environment with high academic standards.
- Incorporate proven instructional methods, quality materials, and a standards-based curriculum taught in the light of God's Word.

OBJECTIVES

CoLCA desires to collaborate with families to see children succeed in all aspects of life. Partnering with families, CoLCA seeks to ensure that children will have what it takes to make a positive impact in our community and beyond. CoLCA desires to serve families by helping their children grow and develop into all God has designed them to be. CoLCA has identified four specific areas in which it will serve students in the process of being prepared for this life and the one to come:

1. CoLCA will partner with families to help students grow within the five domains of development.
 - **Spiritual** – Students will learn to grow in the knowledge and grace of God, trusting in Jesus Christ as their personal Savior from sin through His suffering, death and resurrection. In response to this gift, students learn to live a life of serving Jesus by serving others.
 - **Intellectual** – Students will receive a high quality, well-rounded, Christ-centered education that prepares them for a lifetime of service to God and neighbor. All subjects will be taught in the light of God's Word. It will become evident that God's Word applies to every aspect of life.
 - **Physical** - Recess, physical education classes, and athletic programs will help students grow physically. Students will learn that their bodies are a gift from God and that they accept responsibility for their health, safety, recreation, and rest.

- **Emotional** – Students will learn to recognize that feelings and emotions are real and need to be identified, validated, and aligned with God’s will for his people.
 - **Social** – Students will learn to recognize all people as God’s creation and to show kindness, unconditional Christian love and respect to their peers, family members, pastors, teachers, government authorities, and all God’s representatives here on earth.
2. CoLCA also believes that students need to be equipped for a world that is constantly changing. It is likely that many of the careers CoLCA students will find themselves in do not even exist yet. CoLCA will partner with families to provide opportunities for students to develop the 21st Century skills of
 - **Critical Thinking/Problem-solving – comparing evidence, evaluating claims, & making sensible decisions**
 - **Communication – speaking and writing skills and the ability to process and analyze information through a variety of media formats**
 - **Collaboration – working with others effectively and efficiently to accomplish a common goal**
 - **Creativity/Innovation** – exploring options and designing alternative solutions; “thinking outside the box”
 3. CoLCA will partner with families to provide opportunities for students to develop the life success skills of
 - **Integrity** – honesty manifested by adherence to moral principles
 - **Self-discipline** – self-monitor, delay gratification, and resist temptation
 - **Empathy** – understand the feelings and perspectives of others as decisions are made
 - **Perseverance** – tenacity in difficulty, striving to achieve, never giving up
 - **Clearly defined moral values** – understand Biblical guidance for daily living
 4. CoLCA will partner with families to equip students for readiness in the 4 C’s.
 - **Ready for Christian-living**
 - **Ready for College**
 - **Ready for Career**
 - **Ready for Citizenship**

The blessing of Christian education is that these objectives and qualities are developed with guidance from the scriptural tenets of “Love the Lord your God with all your heart and with all your soul and with all your mind” and “Love your neighbor as yourself” (Matthew 22:37, 39).

EXPECTATIONS

Families can expect that CoLCA faculty and staff will:

- Be prepared to serve students and families each day.
- Reflect faith in Christ through words, actions, activities, and relationships.
- Show joy and enthusiasm for the teaching ministry.
- Demonstrate dedication to the teaching ministry.
- Know the subjects they are teaching.
- Know how individuals grow and develop.
- Understand that individuals learn differently.
- Know how to create and maintain a Christian learning environment.
- Communicate effectively.
- Plan a variety of effective lessons.
- Assess student progress.

- Grow spiritually and professionally.
- Have a servant's attitude in their approach to ministry.
- Encourage each student to work to his or her potential.
- Have a willingness to assist students.
- Be available for students and parents.
- Express the joy of carrying out the Gospel ministry at CoLCA.
- Pray for the students and families of CoLCA.
- Treat students and families with Christian love and respect.

CoLCA faculty and staff expect that students will:

- Have a willingness to participate, cooperate, and learn.
- Take responsibility for class assignments and projects.
- Complete all assignments on time using one's God-given talents to their fullest.
- Go to the classroom teacher when there is a question or problem regarding class work.
- Challenge themselves to succeed at the highest possible level.
- Understand and reflect the joys and blessings of the Gospel ministry carried out at CoLCA.
- Pray for their families and CoLCA's faculty and staff.
- Treat other students, support staff, and teachers with Christian love and respect.

CoLCA's faculty and staff expect that families will:

- Have your child at school on time each day.
- Provide spiritual development opportunities for your child.
- Encourage your child to use his/her God-given talents to the best of his/her ability.
- Regularly discuss school with your child.
- Encourage your child to seek help from his/her teacher when questions or concerns arise.
- Discuss your child's progress with his/her teachers.
- Share with your child and others the blessings of Christian education.
- Pray for your child, the faculty, and staff at CoLCA.
- Partner with teachers for at-home learning opportunities (*i.e.*, homework, family projects, etc.).
- Treat other families, the staff, and faculty with Christian love and respect.

CoLCA strives in every way to follow the scriptural encouragement found in *Colossians 3:17*, "And whatever you do, whether in word or deed, do it all in the name of the Lord Jesus, giving thanks to God the Father through him."

THE LEARNING ENVIRONMENT AT COLCA

CoLCA teachers know how to create and maintain a Christian learning environment. CoLCA teachers use an understanding of the proper use of Law and Gospel as well as individual and group motivation and behavior management to create a learning environment that promotes Christian living, self-discipline, positive social interaction, active engagement in learning and self-motivation. CoLCA teachers:

- Model and encourage Christian living in words and actions.
- Establish an effective learning community in which students assume group- and self-responsibility, participate in decision making, work collaboratively and independently, and engage in purposeful learning activities.
- Organize, allocate, and manage resources (*e.g.*, time, space, activities) to provide equitable engagement of students in productive tasks conducive to classroom goals.
- Establish Christ-centered values and expectations that foster a positive classroom climate of openness, mutual respect, support, and inquiry.
- Analyze the physical classroom environment and make adjustments to enhance social relationships, motivation, engagement, and productive work.
- Organize, prepare, and monitor independent and group work for full and varied participation of all individuals.

COLCA POLICIES AND PROCEDURES

ADMISSIONS

GENERAL GUIDELINES

- Admission to CoLCA is based on availability determined by class size.
- Students will be placed in the grade level that corresponds with their chronological age using September 1 as the cut-off date.
- Crown of Life may administer diagnostic tests to place students at the appropriate academic level.

ADMISSIONS PROCESS

Step 1: Family connects with CoLCA via phone, email, or the CoLCA website and is directed to either schedule a campus visit or complete an *Admissions Application*.

Step 2: Campus visit schedule is finalized, the family visits, and is provided with additional school information including calendar, tuition information, and scholarship information. (This visit should include the prospective student.)

Step 3: Family completes the application and pays the Application Fee. (Students may *shadow* for part of a school day prior to Step 4.)

Step 4: Each family submits all required records, forms, and fees. Documents are reviewed by faculty. Additional screenings and testing may be requested. After final review, a recommendation on admittance is made to the Education Committee, which makes the final decision.

Step 5: Notification from the school office of acceptance, waitlist, or denial for enrollment will be made within five school days of faculty review.

Please Note: Updates of immunizations will be required while students attend CoLCA. Your child's immunization record will be evaluated on a regular basis by the local health department. *Children who do not have updated immunization records (or exemption documentation) cannot be allowed to attend school.*

RE-ENROLLMENT

Step 1: CoLCA notifies families when the early reenrollment period opens on January 1st.

Step 2: Families re-enroll through the online portal or with paper forms, then they submit any necessary documents or fees.

Step 3: CoLCA notifies families when the early reenrollment period ends and confirms that the application is complete.

Please Note: Students who are currently enrolled and their siblings entering the school in the fall will be given priority registration during the early enrollment period, in addition to possible waiver of the registration fee (this will be announced if applicable). However, families who delay registering for the fall may find themselves in a lower priority or even waitlisted after the open enrollment period opens.

STUDENTS WITH SPECIAL NEEDS

CoLCA desires to serve all families with God's Word. However, our limited resources do not allow us to meet the needs of all children, such as those with severe physical or learning challenges. If the staff cannot adequately meet the child's needs, we will suggest agencies through which parents can receive help. These actions are always carried out in the best interests and care of the student and with their educational needs in mind.

ATTENDANCE

Regular school attendance is the responsibility of the family and student. CoLCA believes that consistent school attendance is essential for academic success and that all absences affect learning. Therefore, CoLCA's Student Attendance Policy has been developed to meet the following objectives:

- Raise student achievement and close gaps in student performance
- Identify attendance patterns to design attendance improvement efforts
- Know the whereabouts of every student every day
- Verify that individual students are complying with education laws related to compulsory attendance

State law allows the parent to write notes to document and excuse up to 10 days of student absence for illness or excusable reasons per year; five days in the first term (August-December) and five days in the second term (January-May). Beyond the 5 days in each semester, if a student has a serious reason to miss additional days, the Principal can review parent requests to excuse up to five more days per year, for a total of 15 days per year.

Beyond 15 days per year, only doctor/therapist or court notes can be accepted to excuse absences. It is very important to document all days of absence with a note which must be turned in at school even if the reason for absences does not allow the day to be excused. All additional absences, including time accrued from tardiness, leaving early, or being sent home may be recorded as unexcused absences.

REPORTING ABSENCES

A parent or guardian is asked to call the school office (**239-482-7315**) by 9:00 a.m. to report an absence (unless a notice of a planned absence has been submitted to the Principal or classroom teacher). In the case of families who

do not report an absence, the school will attempt to contact a parent/guardian to determine a student's whereabouts.

When a parent or guardian does not excuse a student's absence, the absence is considered *unexcused*. According to Florida law, students with 15 or more unexcused absences within a 90-day period are considered truant and will be reported to the Lee County School District as such. Repeated unexcused absences could result in the student being dismissed from school or denial for re-enrollment.

ARRIVING LATE & LEAVING EARLY

- Students arriving at school after 8:30 a.m. but before 10:00 a.m. are marked with a quarter-day absence
- Students arriving between 10:30 and 12:00 will be marked with a half-day absence.
- Students leaving school between 12:00 and 1:30 will be marked with a half-day absence.
- Students leaving school between 1:30 and 3:30 will be marked with a quarter-day absence.

When a child arrives late to school in the morning, parents are required to check the child in at the school office. School personnel or a parent will accompany the child to the classroom door.

Students leaving early must check out through the school office. The office calls the student out of class when the parent arrives. The school requests that every effort be made to schedule appointments during non-school hours or on days when school is not in session for students to be present the entire school day.

Students must be in school the entire day to participate in any co-curricular activities. Exceptions are made for pre-approved absences involving scheduled appointments.

TYPES OF ABSENCES

Excused Absences

- Personal illness
- Illness in the immediate family requiring the student to be at home
- Death in the family
- Scheduled medical appointment: If a student is absent from school due to a medical appointment a written statement from a health care provider indicating the date and time of the appointment must be submitted to the child's teacher.
- Quarantine
- Court appearance
- Observance of religious holiday
- Other individual student absences beyond the control of the parent or student, as determined and approved by the Principal or designee. Parents must submit documentation related to the condition.
- Absences due to older students providing child care services for siblings.
- Absences due to non-compliance with immunization requirements (unless lawfully exempted).

TARDINESS

Students are expected to be on time for school and families are asked to make every effort to make this happen. Persistent tardiness will result in time calculated as days absent (even if the student arrived before 9:00 a.m. but after 8:30 a.m.) and could also result in further consequences, including the student's dismissal from school or denial for re-enrollment.

MAKE-UP WORK

Teachers will allow students to make up and receive a grade for tests and assignments missed during an absence. Students typically have one day to make up work for every day of an excused absence. Students are required to make-up work for all absences, truancies, or suspensions. In the event of a planned absence, families may request schoolwork for their child by contacting the classroom teacher. Please keep in mind that the teacher may not be able to provide all schoolwork in advance.

FINAL THOUGHTS ON ATTENDANCE

While 100% attendance is the goal for every student, it is expected that students *will* attend at least 90% of the time. This is especially true for scholarship students. Students who do not attend for the time allotted by the Florida scholarship programs may be in jeopardy of losing their scholarship from the State of Florida. If a student forfeits a scholarship because of attendance, the family will be charged the remaining unpaid tuition for that child.

Attending school regularly and on time is critical for academic success. Arriving to school 5-15 minutes early provides a much need transition time that adds to academic success. When any amount of school is missed, learning opportunities are missed as well, many of which cannot be replicated. CoLCA teachers appreciate your efforts in getting your child to school every day on time. It is best practice for students to be at school every day to make the most of their educational experience and in preparation for life after school.

BULLYING

Definition: Bullying is unfair, one-sided, and is repeated. It happens when there is an imbalance of power and someone purposely and habitually hurts, teases, frightens, threatens, or alienates someone else. Bullying behavior is intentional and repetitive with a negative impact.

CoLCA is committed to making our campus a safe and caring place for all students. Everyone is to be treated with Christian love and respect. Bullying of any kind will not be tolerated. All concerns relating to bullying should be reported to a teacher or the Principal and will result in appropriate consequences according to the discipline policy.

Instances of bullying will be immediately addressed with an individual consultation, resulting in, at minimum, a removal from the classroom and up to expulsion from school.

BULLYING BEHAVIORS MAY INCLUDE THE FOLLOWING:

- Hurting someone physically such as hitting, kicking, tripping, or pushing
- Stealing or damaging another person's things
- Ganging up on someone
- Teasing someone in a hurtful way, or name calling
- Using put-downs, such as insulting someone's physical attributes or appearance
- Spreading rumors or untruths about someone
- Leaving someone out on purpose, or trying to get other kids not to play with someone

STUDENTS AT CROWN OF LIFE CHRISTIAN ACADEMY WILL BE ENCOURAGED TO DO THE FOLLOWING TO PREVENT BULLYING:

- Treat each other with unconditional Christian love and respect
- Refuse to bully others

- Refuse to let others be bullied
- Refuse to watch, laugh, or join in when someone is being bullied
- Try to include everyone in play, especially those who are often left out
- Report bullying to an adult

TEACHERS AND STAFF AT CROWN OF LIFE CHRISTIAN ACADEMY WILL DO THE FOLLOWING TO PREVENT BULLYING AND HELP CHILDREN FEEL SAFE AT SCHOOL:

- Closely supervise students in all areas of the school and playground
- Watch for signs of bullying and stop it when it happens
- Respond quickly and sensitively to bullying reports using the *Four-A Response* process and coaching (Affirm/Ask/Assess/Act)
- Look into all reported bullying incidents
- Assign consequences for bullying based on the school discipline policy
- Provide immediate consequences for those who retaliate against students who report bullying.

CAMPUS VISITORS

All campus visitors are required to sign in and out at the school office. Parents of CoLCA students are always welcome to visit the school. Visits by other adults or by friends of students may also be arranged with the Principal and classroom teacher at least 24 hours in advance of the proposed visit. Unauthorized visitors may be asked to leave the building and campus to ensure the security of our students.

CELL PHONES

The main office is staffed for answering phone calls. If a parent needs to communicate with their child during the day, please contact the office at 239-482-7315.

If parents feel their child absolutely needs a cell phone, the phone must be turned off and kept in the student’s backpack/bookbag before the start of school and remain off while on school property. This includes iPads and cell phones used for music. Students may *not* use their phones for calling, texting, or emailing during the day. Students caught using cell phones during school will have their phone confiscated and a parent/guardian will retrieve the phone from the administration.

COMMUNICATION

CoLCA desires to build a culture where parents and teachers partner together in providing quality Christian education. To that end, the staff of CoLCA is truly committed to maintaining open channels of communication with the families of our students.

Below are some important avenues designed to promote efficient and effective communication:

ORIENTATION/BACK TO SCHOOL NIGHT

In early August, parents have an opportunity to meet with the teachers and the Principal at CoLCA’s Parent Information Night and CoLCA’s Back to School Night to discuss the school’s philosophy, policies, and procedures. These events give CoLCA the opportunity to provide parents information about new policies, reinforce specific policies, and an opportunity to ask questions about CoLCA’s educational ministry. Included with these events are an opportunity for students and families to visit classrooms and meet the teaching staff. Families are provided

information needed for a successful school year and students can bring in their books and supplies in advance of the first day of school.

PARENT-TEACHER CONFERENCES

CoLCA holds formal parent-teacher conferences in the fall and spring of the school year. These conferences provide an opportunity for families to visit with teachers and discuss their child's spiritual, intellectual, physical, emotional, and social development.

TEACHER AVAILABILITY

If at any time during the school year families have questions concerning their child's progress or behavior, they are encouraged to call or email the teacher and arrange a mutually convenient time to meet. The teacher will make every effort to return your call or respond to your email within 24 hours.

CLASSROOM VISITATION

As part of CoLCA's open-door policy, parents are welcome to visit their child's classroom and see education in action. Parents may participate in classroom activities or just come and observe. Prior to the visit, schedule a day and time with your child's teacher. The day of your visit, you will check in to create observation goals and check out to review the goals with the Principal.

DROP-OFF/PICK-UP

Families may drop off or pick up from designated areas or walk to the classroom and connect with the teacher. This is not the time to discuss concerns or sensitive issues, but it can be used to set up a future meeting.

VOLUNTEERING

Parents are welcome to volunteer at CoLCA. Opportunities are plentiful. Whether it's one day a month or one day a year, please consider being a part of your child's classroom experience. Your presence enhances your life, your child's life, and our educational programs as well. If interested, please contact your child's teacher or the Principal.

WEEKLY UPDATE (E-NEWS)

Classroom teachers will typically send home a weekly email or newsletter to inform families of classroom news and events.

WHEN CONCERNS ARISE

We realize that at times problems or misunderstandings between home and school will arise. It is not good to leave these matters to themselves, even for a short period of time. If at any time you have a question or concern, please follow the process below which is based on Christ's instruction given to us in Matthew 18. "If your brother or sister sins, go and point out their fault, just between the two of you. If they listen to you, you have won them over. But if they will not listen, take one or two others along, so that 'every matter may be established by the testimony of two or three witnesses.' If they still refuse to listen, tell it to the church; and if they refuse to listen even to the church, treat them as you would a pagan or a tax collector. (Matthew 18:15-17) It is the aim of this process to resolve any problems in a God-pleasing manner.

Parents are encouraged to address concerns directly with the person or people involved in the issue, whether it be another parent, a teacher, a school administrator, or anyone else about whom a parent has a concern. If a

parent has a concern about a teacher or another member of CoLCA's staff, the parent is encouraged to address that concern with the staff member directly, and if that fails, then to the Principal. However, the leadership of Crown of Life Lutheran Church, which oversees CoLCA, has an open-door policy. Any parent may bring concerns directly to the Education Chairman, the President of the Church Council, or the Church Pastor. Such leaders are empowered to take action as necessary, including but not limited to helping facilitate a resolution and taking any other follow-up action that they determine necessary or desirable under the circumstances.

If your child comes home and shares with you something of concern, it is often best to reach out to your child's classroom teacher and ask the question beginning with three important words, **"Help me understand..."** A classroom teacher may not be aware of an issue your child shares. This question provides an opportunity for families and teachers to work together for the good of the entire school community. It is important to remember to speak the truth in love as brothers/sisters in Christ.

Under no circumstances should families express concerns or frustrations with the school, a teacher, or other students on a public platform or via social media. This type of behavior is harmful to campus culture and will not be tolerated. Inappropriate use of social media on the part of a CoLCA family could result in a student's dismissal from or denial of re-enrollment to CoLCA.

CURRICULUM

The curriculum at CoLCA seeks to enrich the mind and enlighten the heart through the timeless truths of God's Word. CoLCA's curriculum is designed to meet the diverse needs of learners, gives encouragement to use one's gifts to God's glory, and is based in part on learning standards set forth by the Florida Department of Education.

BIBLE INSTRUCTION

Each classroom has a daily Bible lesson. Students in Kindergarten through Grade 5 use the One in Christ Bible curriculum from Concordia Publishing Company. Students are encouraged to dive into God's Word and make personal applications in all grade levels. Hymns and worship songs are studied in all grades.

A unique component of the religion curriculum at CoLCA is memory work. Each week, students in grades 2-5 are assigned scripture passages, parts of the Catechism, and hymns for memorization and recitation. Students in grades K-1 complete memory work in class. CoLCA believes there is academic value in memorizing and spiritual value beyond compare when God's Word is in the hearts and minds of His children.

LANGUAGE ARTS

A clear understanding of the English language is imperative for success in all areas of the curriculum and everyday life. CoLCA's language arts curriculum accomplishes this through its integration of reading, phonics programs, vocabulary, writing, spelling, grammar, and oral expression in a sequential and developmentally appropriate order. Students in grades K-5 use programs from Collaborative Classroom, either Being a Reader, Making Meaning, or Book Clubs and Being a Writer as the foundation for instruction in Language Arts.

MATHEMATICS

A traditional, hands-on approach to mathematics instruction at CoLCA gives students a firm foundation in computation, math concepts, problem solving strategies, and data interpretation. Concepts are introduced sequentially moving from concrete to abstract. Kindergarten through 5th Grade utilize Bridges in Mathematics and Number Corner from The Math Learning Center. A strong connection between home and school is included in a Home Connections workbook that reinforces learning at home.

SCIENCE

The science curriculum at CoLCA leads children to a greater appreciation of the awe-inspiring world in which they live. By means of textbook investigation, high-quality children's literature, hands-on experimentation, group projects, and technology-aided presentations, students discover various aspects of physical, earth, and life science. Special emphasis will be placed on developing skills such as observing, comparing, hypothesizing, predicting, measuring, testing, and interpreting.

SOCIAL STUDIES

The scope of study in CoLCA's social studies curriculum includes exposure to a variety of social science disciplines: world cultures, values and customs, history, geography, sociology, current events, economics, and civics. Instruction and activities in these areas are structured to help young students develop skills such as critical thinking, decision-making, cause-and-effect relationships, and reading charts, maps, and graphs. History is taught with a Biblical worldview providing students with discernment and the necessary tools to be active, well-adjusted citizens and leaders in today's world.

TECHNOLOGY

The development and use of modern technology continue to evolve and shape our lives. Students are given the opportunity to develop familiarity with the physical structure of computers and with operating various computer programs to supplement cognitive growth. Classrooms are equipped with computer equipment, interactive screens, educational software, and high-speed Internet access.

MUSIC

CoLCA's music program contains the integrated components of music theory and music appreciation. Music instruction is designed to teach basic elements such as notation, rhythm, and music terminology to prepare students to read music and explore musical instruments. Vocal skills are developed through pitch exploration, ear training, and classroom singing.

ART

Art is a gift from God and CoLCA's program from Kindergarten to Grade 5 is unique with the emphasis on providing students with the opportunity to explore a wide variety of mediums. Concepts such as line, shape, form, color, pattern, design, and composition are developed in an art curriculum that allows children to express their creativity and discover their talents. Young artists learn to value not only the product, but also the process. The children also enjoy exposure to well-known artists, their unique styles, and classical works as well as a connection to art and history. Other goals include development of fine motor skills, improvement of hand-eye coordination, and experiences in collaborative learning.

PHYSICAL EDUCATION

The goals of CoLCA's physical education program include instruction in the rules, skills, and strategies of team and individual sports, physical fitness and cardiovascular development, practical experiences in leadership, teamwork, and sportsmanship, and development of a positive self-image in a safe, structured environment. CoLCA uses the SPARK physical education curriculum in Kindergarten – Grade 5. Expectations include participation in all games and activities, respect for peers and instructors, proper care of equipment, and cooperation.

The P.E. program is designed to enable each child to achieve success while developing an interest in life-long physical activity. Participation in P.E. for students with medical problems or physical limitations will be modified as needed.

SPANISH

Students in Kindergarten – Grade 5 receive basic instruction in Spanish from fluent Spanish speakers. Interactive lessons and the use of technology engage students as they explore vocabulary and conversational rules and phrases.

ROTATIONAL SPECIAL COURSES

CoLCA utilizes the strengths of our individual teachers to provide unique rotational specials throughout the year. Students are provided with a well-rounded education as they are introduced to different topics and interests. Examples of possible topics include Geography, Gardening, Handiwork, Cooking, Home Tech, and Photography.

CONDUCT AND DISCIPLINE

All students are expected to obey and show respect to those in authority. Hebrews 13:17 serves as a guide, "Obey your leaders and submit to their authority. They keep watch over you... Obey them so that their work will be a joy, not a burden, for that would be of no advantage to you." Students are also expected to be considerate, kind, and courteous toward each other. Matthew 22:39 states, "Love your neighbor as yourself."

Upon enrolling a child at CoLCA, a parent gives his child's teacher the authority to carry out the disciplining of the child while attending school or any of its functions. The parents can expect that CoLCA's teachers will correct their children properly in the spirit of Christian love and concern.

In all cases of discipline, CoLCA's personnel will act with utmost love for the children and with their best interest in mind. We exist to partner with parents in *helping their child become all Christ calls them to be*.

In general, discipline is part of classroom management and is handled by the teacher. The exceptions to this are detentions, probations, suspensions, and expulsions, which involve the Principal and the Education Committee.

Disciplining as a Teaching Process

CoLCA's discipline program is based on the proper application of Law and Gospel. The Law condemns and curbs a person's sinful nature as it shows the undeniable need for a Savior. But it is the Gospel (good news) of Christ which changes the heart and motivates a person for true discipleship. Simply put, the discipline program at CoLCA is reflected in these three objectives:

- To teach, model, and reinforce appropriate behavior.
- To stop inappropriate behavior.
- To promote personal responsibility and accountability.

Each student is a unique child of God with unique personal, social and educational needs. As a result, every disciplinary situation becomes unique in nature. Consequences for misbehavior provide the best learning value when matched to the unique student and the unique situation. The odds for children learning from their mistakes increase dramatically when children see a reasonable connection between their behavior and the resulting consequences.

Our school staff dedicates itself to following a set of principles that provide a guide for dealing with student discipline. These principles guide our attempts to individualize disciplinary procedures and to help students see reasonable connections between their behavior and the resulting consequences.

Since these principles provide the guiding light for our professional decisions, the staff encourages parents to bring concerns and questions to us in the event we operate in ways that appear to be inconsistent with these core beliefs.

Principles for Addressing Misbehavior

- Students will be shown their sin with the use of the Law and guided in God-pleasing behavior with Gospel motivation.
- Students should respect all those in authority (teachers, pastors, staff, and parents) according to the 4th Commandment.
- Students should be guided and expected to solve the problems they create without making problems for anyone else.
- Misbehavior should be handled with natural consequences instead of punishments whenever possible.
- There should be a logical connection between the student's behavior and resulting consequences.
- Every attempt should be made to maintain the dignity of both the adult and student.

In no instance will physical punishment be used (*e.g.*, spanking), nor will discipline be related to food, rest, or toileting. We will also not use discipline that is abusive, frightening, humiliating, or neglectful. We prefer to give encouragement for and praise of good behavior, while offering corrective guidance and redirection for improper behavior/attitudes. We do our best to anticipate problems and redirect a child's activities. We will narrow choices if necessary. Positive words will be used to encourage positive behavior. We will encourage children to use words to express themselves.

If a child is exhibiting an inappropriate behavior, the child will be told they need to stop, explain why the behavior is unacceptable, and offer reasonable alternatives. Logical and natural consequences as well as temporary loss of privileges may be used as a reasonable alternative. If the child is repeating inappropriate behavior, the parents will be consulted.

Under most circumstances, discipline follows a progression until the desired outcome is reached. This progression would include discussions with the student, teacher, parents, Principal, Pastor, and Education Committee as appropriate.

To maintain a high-quality learning atmosphere and educational program, students who consistently break the rules set by CoLCA will be disciplined appropriately. If corrective action is not taken on the part of the student, along with any necessary encouragement from his/her family, the student may be asked to leave the program.

Disciplinary Procedures

The discipline process is initiated as follows:

1. The infraction is brought to the student's attention.
2. The incident is documented by the teacher, and parents have the right to receive copies of such documentation.
3. The teacher and student work together to achieve resolution. This may result temporarily in extra duties or the loss of privileges for the student. Whenever consequences are administered, they will be consistent, logical, and motivated by love for the child.
4. Parents may receive a phone call, hand-written note, or email message from the teacher indicating the concern.
5. A teacher or the Principal may request a parent conference in which behavioral issues are identified and solutions are discussed.
6. A student may be placed on a behavior management plan to guide the student towards more appropriate behaviors.
7. A student may be suspended for continued violations of school rules or for extreme, disruptive, or dangerous behavior. A suspension may be 1, 3, or 5 days and may be served at home or in the school as

directed. The Principal, in consultation with the Education Chairman, may institute a suspension, which is reviewable by the Education Committee.

8. If a student persists in his or her lack of cooperation as indicated by an unwilling spirit, rebellious behavior, or unacceptable attitude, the Education Committee may expel the student from CoLCA.

Disruptive Behaviors

Disruptive behaviors are of high concern. Disruptive behaviors are described as distractions or interruptions that cause student learning to pause, stop, or restart from a previous point but are not a health or safety issue. They are distracting and interrupt the learning process. They negatively impact the ability of students to learn, focus on lessons, or work independently. It is important to the faculty of CoLCA to protect the learning environment to be productive and effective. Teachers create procedures for multiple classroom tasks to minimize disruptions to the learning environment. To keep the lesson going when disruptions occur, teachers will use quick non-verbal or verbal interventions and kind redirection. Depending on the frequency and severity of disruptive behaviors, a student may be referred to a school administrator to be removed from the classroom for a time or sent home. Should a student be sent home for disruptive behaviors, class time missed will be recorded as an absence.

Situations which are considered extreme or presenting a danger, as determined by the Principal, are dealt with immediately. This will result in disciplinary action up to expulsion.

DAILY WORSHIP

Students at CoLCA will have multiple opportunities to worship our Lord throughout the week. Teachers will conduct classroom devotionals and the student body will meet for a chapel service led by Crown of Life Lutheran's pastor each Wednesday. Chapel services will also give students the opportunity to bring an offering for the Lord to support a mission project beyond the CoLCA campus.

DRESS CODE

The following dress code has been developed in accordance with Crown of Life's commitment to excellence in education. CoLCA has developed standards of dress which are conducive to a positive learning environment and reflect pride in our school. As Christians, we want to reflect modesty, neatness, and appropriateness in our appearance as we reflect Christ in our daily lives. Students are expected to wear the school uniform Monday - Thursday and have relaxed wear, adhering to these guidelines, on Friday. CoLCA's school colors are blue and gold. Polos in royal blue, light grey, and white are highly recommended but not required.

GIRLS' Dress Code

Monday – Thursday: Uniforms

- Solid colored polo shirt
- Khaki/tan, navy, or black bottoms
 - Skorts, Shorts, and pants are acceptable. Pants must have pockets.
 - Skirts and Jumpers must be worn with shorts or leggings underneath.
 - Shorts must be fingertip length or longer.
 - Leggings alone are not permitted.
- Solid colored uniform dresses are also acceptable but must be worn with shorts or leggings.
- Closed toe shoes are recommended and tennis shoes/sneakers are required on P.E. or sports days.

BOYS' Dress Code

Monday – Thursday: Uniforms

- Solid colored polo shirt
- Khaki/tan, navy, or black bottoms
 - Shorts or pants are acceptable. Pants must have pockets.
- Closed toe shoes are recommended and tennis shoes/sneakers are required on P.E. or sports days.

GENERAL GUIDELINES

- Jeans (shorts, pants, skirts, etc.) may only be worn on Fridays unless otherwise stated. **Jeans are to be free of rips, holes, etc.** (Jeans – shorts, skirts, etc. must meet the length guidelines above)
- Clothes must be neat, clean, and in good repair.
- Friday relaxed wear clothing may be CoLCA logo wear, plain t-shirt, or multi-colored polos.
- For safety reasons, excessive jewelry and dangling or hoop earrings are not allowed. Small earrings may be worn.
- Hair is to be neatly brushed or combed.
- Out of the ordinary hair styles should be avoided.

UNIFORM VIOLATIONS

Students who come to school without the appropriate uniform apparel will receive a uniform violation notice from the classroom teacher to be signed by a parent or guardian and returned the following day. Repeated uniform violations may result in an immediate parent notification with a request for appropriate apparel to be brought to school.

FIELD TRIPS

Field trips are a part of your child’s educational experience at CoLCA. Field trips will be announced well in advance of the trip’s date. Prior to a school or classroom field trip each family will receive a letter explaining the trip along with a permission form. Families must complete and return the permission form promptly to avoid a situation in which a child would not be able to accompany his/her class on a field trip. Except as otherwise communicated, field trip costs for students are included in the registration fees. End of the year “fun” school field trips are one example of field trips that are not included in the registration fees. Students who do not attend field trip opportunities may stay home or return home. However, this will be recorded as an absence.

Drivers and chaperones will be needed, as bussing is not provided. All field trip drivers must have a completed *Volunteer Driver Form* and supporting documentation on file in the school office.

GRADING

Assessing student progress is a critical element of the teaching process. Accurate evaluation of learning directs and guides teaching. Teachers engage in daily ongoing assessment of students’ understanding and proficiency as the basis for choosing and moving from one instructional sequence to the next.

Students in Grades 3-5 will be graded using the following scale:

Students in Kindergarten through Grade 2 are assessed on their progress towards grade level standards. Supporting documentation will be provided at the end of each grading period.

Related arts in Kindergarten through Grade 5 are given attitude and effort grades.

- E – Excellent
- S – Satisfactory

REPORT CARDS

Student progress is graded and officially recorded on the quarterly report card. Quarterly report cards are printed and sent home at the end of each grading period.

PROMOTION

The promotion of each student from grade to grade is based upon the student's satisfactory achievement of required class work. A child will not be retained without previous consultation with the families. Promotion is based on achievement standards the school has established and the God-given abilities of the student.

FOOD

Encourage your child to eat something nutritious before coming to school. Children who do not eat breakfast may be quite sluggish until snack time. The child's attention span may be affected, preventing optimal learning during class time.

Snacks

CoLCA does not provide snacks. Students should bring a snack for the morning and afternoon break. If your child will be attending the extended program following their school day, please send an additional snack and drink. A water bottle is required for each student, in addition they may bring juice pouches for snack or lunch.

Lunch

CoLCA may facilitate a hot lunch service but does not offer a full lunch program. Should parents have lunches delivered to school, they must arrive by 11:00 a.m. to ensure students are able to eat on time. Students may bring their own cold lunch and drink. Students will not have access to microwaves, refrigerators or plasticware.

Treats

Children can bring store-bought treats for their birthdays or other special occasions. The treats will be distributed and eaten at an appropriate time, at the discretion of the teacher. Please check with your child's teacher at least 24-hours before a treat is brought to school about the timing of the treat and the contents of the treats (since some students have allergies). Additionally, classrooms may be required to be free of peanuts and other foods or allergens (*e.g.*, latex).

Please Note: To best protect students from allergic reactions or violating dietary restrictions, students are not permitted to share, exchange, or bring food for other students without the teacher's express permission AND the parent's full knowledge.

GRADUATION GUIDELINES

Only students who are currently enrolled and have passed/completed the pre-approved classes set by administration of CoLCA, will be eligible for graduation from Grade 5. In addition, all tuition and fees must be paid in full to the school prior to the student participating in any graduation ceremonies and/or transferring records.

HEALTH AND SAFETY

IMMUNIZATIONS AND HEALTH FORMS

Florida law requires that all students have the necessary forms on file by the first day of class. Students cannot begin classes at Crown of Life without a current, completed physical exam form and proper documentation of up-to-date immunizations. Forms are available from your doctor.

MEDICATIONS

If your child must have prescribed or non-prescribed medication, oral or topical, during school hours, the medication must be in the original container with specific instructions in writing. This should include the child's name, medication name, dosage, and time to be taken. Parents must include written authorization for non-prescribed internal or external medication. Parents are asked to deliver the medication directly to a teacher. Refrigeration will be available for those medications requiring it. *If medication—including sunscreen or bug spray—is to be given during the day, a medical release and authorization form will need to be signed.*

ILLNESS

Parents are responsible to inform the school when a child is or will be absent for any reason. For more information, please reference our attendance policy. In the case of illness, the staff would appreciate knowing the nature of the illness in case it might be contagious. When advisable, a release form from the physician will be necessary for a child to return to school. A parent may excuse a child from school by calling the office: 239-482-7315.

If your child arrives at school with the following symptoms - fever (greater than 100.4, nausea, runny nose, sore throat, flushed appearance, abnormal irritability - or develops these symptoms while at school, the parent/guardian will be notified and asked to take their student home as soon as possible. **The child must not come back to school until they are symptom free for 24 hours (this includes diarrhea, vomiting, or fevers of 100.4 degrees or higher).**

EMERGENCIES

Medical emergencies may, on occasion, occur at school. In the event of a life-threatening situation (example - unconsciousness), the school may need to contact the appropriate emergency medical service first, before calling the parents. In case of an accident or illness where immediate emergency care is not deemed necessary, but where a child is unable to remain at school, the school will contact the parents to arrange transportation home. Likewise, if a child shows symptoms of illness during the day, the child will be isolated, and the parents will be called.

Parents, please remember that the school must always be able to reach you. If neither parent can be reached at home, work, or cell, the emergency contacts listed on the child's emergency card will be phoned and asked to pick up the child.

If for any reason during an emergency, the children cannot stay on school property, they will be taken somewhere safe, and parents will be notified where they can pick up their child via email, phone, or SMS.

MINOR ACCIDENTS

All minor accidents – cuts, scratches, bumps, and bites are given First Aid treatment and recorded with accident reports. Parents/guardians will be informed of the specific event.

SERIOUS INJURIES

If your child suffers a serious injury, the school will call 911 and will then call the parents; provide First Aid until help arrives; and determine who will accompany the injured student to the hospital. An Accident Report form will be completed describing the nature and extent of the injury. **All head injuries will be reported to parents.**

LICE

If lice and/or lice nits (eggs) are discovered on any student(s), a “no nit” policy will be followed. CoLCA understands how difficult it is to rid the hair and scalp of all the eggs related to lice, but also recognizes how easily lice can be spread. Therefore, if your child is sent home with lice and/or nits, they will not be allowed back into school until they are free from all nits for 24 hours. Students must receive clearance from a health care professional before returning to school or be checked/cleared by CoLCA personnel.

SEVERE WEATHER

Whenever possible the Principal will inform faculty and staff of area weather warnings issued by the National Weather Service.

EMERGENCY EVACUATION DRILLS

In compliance with state regulations, evacuation drills are performed once a month. For the safety of all, detailed drill procedures are shared and periodically reviewed in each classroom.

HOMEWORK/SCHOOL WORK

Homework/schoolwork is not a means to itself, but rather the unfinished portion of classroom work used to practice new skills, reinforce lessons, or assess student learning. You can expect that your child may bring home some degree of work most school days. Some rough guidelines for homework time are as follows: Grades one and two about fifteen to thirty minutes per night, Grades three through five about thirty minutes to one hour, Grades six through eight about one hour to ninety minutes. Please call your child's teacher if your child regularly spends an extraordinary amount of time on his/her homework.

All assigned homework/schoolwork, whether it is done at school or home, is expected to be completed and handed in on time.

INVITATIONS TO PERSONAL, NON-SCHOOL RELATED EVENTS

If invitations are brought to school to be distributed for parties, an invitation must be given to each student in the class. If you do not care to invite the entire class, please send invitations another way, outside school hours.

PROPERTY DAMAGE

Damage done to any church or school property, whether willful or accidental, must be paid for by the responsible party. Arrangements for the repair or replacement of the damaged property should be made with the school administration.

SCHOOL CLOSING

In the case of severe weather, we will follow the closing announcements of the Lee County School District. Whatever action the Lee County Schools are taking, CoLCA will do the same and will be announced through local media outlets. If for any other reason the school needs to be closed, you will be notified via Facebook or emails.

SCHOOL HOURS

CoLCA is open from 7:30 AM to 5:30 PM. Extended care is available at an additional cost for students in Kindergarten through Grade 5 for students needing to arrive prior to 8:15 AM or stay beyond 3:30 PM

Before School Care	7:30 AM - 8:15 AM
Grades K-5:	8:30 AM - 3:30 PM
After School Care	3:30 PM - 5:30 PM

ARRIVAL/PICK-UP PROCEDURES

- Turn immediately to the right upon entering the parking lot. Then drive around the circle to park or enter the carline. Always enter to the right and exit to the left with your vehicles.
- Students arriving prior to 8:15am are to be signed in to extended care by a parent or guardian.
- Parents may park in the lot and bring their children to the classroom between 8:15-8:30 AM.
- Parents may utilize the carline to drop off or pick up students at designated areas only, as marked by a cone or sign.
- After 3:45pm, students will be signed in to extended care with the time recorded as 3:30.

If someone other than the designated person(s) will be picking up your child, please inform this person they are required to show their driver's license. We will not release your child to anyone we cannot verify as an authorized person. Late pick-ups will result in extended care fees.

SCHOOL PICTURES

School pictures will be taken each year, generally in the fall. Pictures may also be taken throughout the year and used on social media, CoLCA's website, in newsletters, and other promotional materials. If you have given your consent to your child's picture being taken, you consent to all uses. Once consent has been given, digital and print media will not be revised if consent is later withdrawn.

SECURITY

CoLCA strives to be a secure campus and is equipped with secure entry points. Signs notify visitors that they must report to the school office. Visitors are required to sign in and sign out. The staff has been advised to approach any unfamiliar visitors and ask how they may be helped. Students who see unfamiliar people or suspicious activity should inform one of the staff members immediately.

STANDARDIZED TESTING

Three times a year, students in Grades 1-5 are tested using the national NWEA Measure of Academic Progress (MAP) Growth tests. These tests are used to measure individual academic growth and development and assist in planning and addressing curricular needs for each student, class, and the school. Individual student growth goals will be set and monitored. Class and school wide growth goals will be displayed, monitored, and celebrated. Results are shared with parents after each testing period. Results of the MAP test will be used to set learning goals and provide opportunities for at home learning.

TECHNOLOGY

Students at CoLCA will have access to multiple kinds of technology. Students are expected to use technology in a manner which gives glory and honor to God. Families and students will agree to abide by any applicable policies of CoLCA regarding technology usage. Inappropriate or reckless use of technology may result in loss of privileges or other discipline as appropriate. Damage to or replacement of such technology will be the responsibility of the parents.

TUITION AND FEES

Tuition and fees are determined by the Education Committee and the Church Council. Prior to the beginning of the enrollment process, tuition rates and all fees (application, registration, and extended care) will be available for families. A current tuition and fees schedule is available in the school office and on the website.

CoLCA recognizes that attendance at a Christian school requires a commitment of time and financial resources on the part of families. We are thankful for the willingness of families to make this commitment for the benefit of their children. With that in mind, CoLCA wants parents to be aware of various tuition assistance and scholarship programs.

Each scholarship requires the family to apply and provide specific information. It is the responsibility of the families to complete all required forms on time to be considered eligible for any of these scholarships. In most cases, scholarship checks are sent directly to CoLCA and are co-endorsed by the family. If a student withdraws from

CoLCA prior to the end of the school year, any scholarship funds remaining on the student's account are returned to the scholarship granting organization.

The members of Crown of Life Lutheran Church have established a scholarship fund that varies based on the amount of donations received and the amount of funds awarded. Eligibility is based on financial need, a demonstrated commitment to Christian education and Crown of Life's mission, and other criteria as determined by the Education Committee. No scholarship applications will be considered without a copy of both parents' or guardians' most recent federal tax returns.

FINANCIAL POLICIES

CoLCA maintains its ability to offer a high-quality Christian education with qualified teachers through the tuition and fees it collects. It is necessary that all balances be paid in full and on time. Your cooperation with the following is appreciated!

- Parents may opt for one of two payment plans: (1) 10-month payment plan or (2) pay in full up front.
 - Families opting for the 10-month payment plan may roll registration, extended care, and activities fees into their tuition payment plan. The first payment will be due at the time of registration and will include the registration fee and book fee. The first month's tuition will be due on the first day of school, and subsequent tuition payments will be due on the first day of each month, starting on September 1st.
 - Families opting to pay in full up front will receive a 5% discount on tuition, on top of any other discounts, such as sibling discounts.
 - The registration fee will be waived if registered by March 31.
 - A sibling discount of 10% will be given for each additional student.
- Scholarship students are expected to pay the difference between what the scholarship pays and the yearly cost at CoLCA (divided by 10 if the parents opt for the 10-month payment plan).
- There will be **no proration or rebates of any prepaid fees for any student during any month**, including if your child is absent for vacations, sickness, etc.
- All balances from a previous school year must be paid in full for a child to return for the upcoming school year and prior to the release of final grades. Special circumstances can be brought to the attention of the Crown of Life Education Committee for consideration.
- If tuition is not paid by the middle of the month in which it is due, the bill will be turned over to the Principal. If the tuition is not paid by the end of the month, the student will not be allowed to attend class until it is paid or arrangements have been made with the Principal. Any alternative payment plan must be approved by the Education Committee. Families with an outstanding balance more than 60 days past due (of any amount) may jeopardize continued enrollment at CoLCA. In addition, in such cases, a bill collection service may be called and an additional fee of up to 40% may be added to the account.
- A late charge of \$50 will be added on the fifth day of the month unless arrangements have been made with the Principal.
- Students entering Grade 5 must have their account paid in full prior to graduation.
- If a student withdraws prior to the end of the school year, tuition and extended care fees can be refunded on a prorated basis. Should there be a balance on the account, student records or grades will not be released.

CoLCA seeks to work with all its families. If there is a concern about tuition payments, please contact the Principal.

CLOSING THOUGHTS

CoLCA is operated under the guidance and authority of Crown of Life Lutheran Church. Through the school, children are taught the precious truths of God's Word across the curriculum. The school does not take the place of the family's role in educating children; rather the school exists to partner with parents in this important responsibility. It is the desire of the CoLCA faculty and staff to create a culture of cooperation, high expectations, and mutual respect as we work together to carry out the task our Lord has placed before us – helping children become all Christ calls them to be.

This Family Handbook does not include every situation that may possibly arise during the school year. If any situation not specifically covered should arise, in Christian love, the administration will make every effort to act fairly and quickly. The best interest of the student, school, and God's kingdom will be considered. Each situation is different and will be handled on an individual basis.
